Are you who we are looking for?

We are looking for people with ambition to develop themselves both personally and professionally, who want to play an active role in helping to shape the new Policing and Community Safety Authority (PCSA) and fulfil its statutory mandate.

We are growing as an organisation and one of the first roles we are seeking to fill is that of Higher Executive Officer within the area of Oversight Delivery. This management position (Higher Executive Officer) offers an opportunity for an ambitious, enthusiastic and committed professional - with a strong commitment to serving the public interest to influence and contribute to the development of the PCSA. S/he will support the shaping of the PCSA's Oversight Delivery services in Ireland to meet the challenges of a dynamic multicultural and modern society. This person must believe in the purpose of our organisation, align with our values and want to support our ambitious growth over the next three years.

The Policing and Community Safety Authority

The PSCS Act 2024 commenced on 2nd April 2025 and provides for the establishment, and functions, of the PSCA – see <u>Policing, Security and Community Safety Act 2024 (irishstatutebook.ie)</u>. The PCSA's primary objective is to oversee and assess the performance of An Garda Síochána in providing a policing service to the benefit of the safety of the public.

The establishment of the PCSA also provides for an exciting opportunity for the establishment of an outstanding policing oversight and inspection regime in Ireland. Broadly speaking, the PCSA incorporates the roles of the Policing Authority and the Garda Síochána Inspectorate, bringing oversight and inspection together in a single organisation.

Purpose and Values

We are looking for people to join us whose personal values align with our purpose and corporate values, and want to be part of an organisation which adheres to these guiding principles. jurisdictions and our research.

The purpose of the PCSA defines not just what it does, but how it does these things and the positive impact on society in Ireland that it is aiming to have. It will provide a clear context for daily decision making and will unify and motivate our staff and stakeholders.

The PCSA purpose is also to help achieve an effective policing service that meets the needs of communities in Ireland in all their diversity through our oversight role. The PCSA will hold An Garda Síochána to account for the delivery of policing services, ensuring a focus on human rights across all areas of policing and promote excellence in the delivery of policing services to all communities. We will work with community stakeholders and our inter-agency partners to promote effective collaboration in support of policing and community safety outcomes.

Our work will be conducted in an open and transparent manner.

Our findings and recommendations will be evidence-based, and we will draw on recognised good practice and, standards of police accountability from other

PCSA Values

Overview of the Role

The Role

We are seeking a Higher Executive Officer (HEO) to work within the area of Oversight Delivery within this directorate of the PCSA.

This management position in Oversight Delivery function of the PCSA will have responsibility to conduct inspections and performance assessments of An Garda Síochána. The key deliverable for these areas within the broader oversight function will be to contribute to the assessment of how An Garda Síochána is delivering its policing service function.

The inspection teams will conduct inspections of specific aspects of the operation and administration of An Garda Síochána relating to policing services, which will vary in duration and nature. The performance assessment team will contribute to the assessment of policing performance with reference to the Policing Priorities, annual Garda Síochána Policing Plan (Service Plan) and having regard to thematic areas within policing that impact public confidence. These activities provide a valuable input into oversight monitoring and reporting.

The successful candidate will also play a key role in the PCSA by influencing its capacity to perform its statutory functions effectively in a complex environment.

Key Role Responsibilities:

Reporting to the Assistant Principal, Oversight Delivery, The HEO will be part of a team responsible for developing and managing the PCSA oversight function including, but not limited to, the following responsibilities:

- Contributing to the management of staff and resources within the PSCA and supporting and role modelling the values of the organisation;
- Supporting the scoping, planning, management and delivery of inspections, collaborating closely with performance assessment and strategy and research colleagues to create an integrated approach to oversight;
- Supporting the scoping, planning, management and delivery of the performance assessment framework including contributions to the determination of Policing Priorities;
- Working cohesively with other functional teams within the PCSA to appropriately share knowledge and optimise the outcomes for oversight delivery;

- Preparing and managing Information Requests to the Garda Síochána and other stakeholders;
- Delivering briefings and debriefings, when required, to the wider PCSA team, covering the identification of findings and any performance issues identified;
- Participating in all aspects of the oversight work including interviews, focus
 groups and meetings to ensure these obtain necessary information/evidence;
- Supporting the development and drafting of, and at times authoring, inspection or oversight reports;
- Collaborating with other PCSA teams to access supporting information including areas such as policing practice, criminal legislation, the criminal justice system, and international best practice;
- Collating, analysing and summarising all findings and data;
- Overseeing the production of the final reports including copy editing, design, quality checking, printing and publication;
- Producing high quality notes and other related oversight reports, as requested, to include collation of observations and fact checking from relevant stakeholders;
- Proactively building robust and effective working relationships with a range of stakeholders including An Garda Síochána, Government departments, key state agencies and communities nationwide, identifying key issues to inform policing performance oversight;
- Contributing to the work of the PCSA overall by drawing on the outcomes of
 inspections or performance assessments and identifying where they are
 relevant to other areas of work e.g. the development of strategy and policy,
 policing priorities for the Garda Síochána, the identification of areas for
 inspection and performance assessment topics; and
- Such other functions as may from time to time be required to fulfil the business objectives of the PCSA.

Essential Role Requirements

On the closing date of 14th May 2025, to be eligible for consideration, a candidate must satisfy all of the following requirements:

a) Be serving in a permanent, temporary or acting capacity in the Civil Service in a grade below that of Higher Executive Officer or equivalent

b) Have completed not less than two years' service in the Civil Service. Temporary officers and officers serving in an acting capacity in the eligible grades may compete in the competition provided they fulfil the eligibility requirements set out above. All forms of maternity leave, including extended maternity leave, constitute service for the purpose of calculating the two-year service requirement in the Civil Service (see Letter to Personnel Officers dated 10 March 2009 – Extension of Probation due to Maternity Leave and Competitions for Promotion).

Where an officer was acting or serving on a temporary contract and was subsequently appointed in a permanent capacity, eligibility may be based on the aggregate service, e.g. six months in an acting capacity or on contract and eighteen months in a substantive capacity, can be aggregated to give two years' service.

- A minimum of 3 years' experience in a similar role, preferably with experience in policing oversight, performance assessment and inspections;
- Excellent decision-making and critical analysis skills to deliver informed conclusions and recommendations;
- Excellent oral communication skills combined with the confidence to engage and influence a range of stakeholders at different levels;
- Excellent written communication skills with an ability to write in plain English;
- The ability to prioritise and work under pressure;
- A track record in managing multiple projects and delivering results in a cross-functional environment; and
- Excellent organisational skills and an ability to organise and maintain databases of information.

<u>Desirable Role Requirements</u>

- Third level / professional qualification relevant to the area of oversight and / or inspections;
- Relevant policing expertise, knowledge and experience; and
- Oversight, inspections and / or regulatory experience.

Person Specification

In addition to the capabilities required for Higher Executive Officers, as set out in appendix 2, the person selected for this post will have:

- Proven ability to communicate effectively and to establish and develop effective relationships with a broad range of stakeholders and to engage with those stakeholders in person on a regular basis;
- Experience of managing multiple workload demands, and working to tight deadlines:
- A willingness and capacity to assume the levels of responsibility and accountability required to carry out a range of professional and operational functions:
- Leadership ability along with organisational and management skills which will inspire, motivate and develop people;
- Excellent verbal and written communication and the capacity to influence and work effectively with a broad range of stakeholders in a constructive manner;
- Sound judgement, problem solving and decision making skills are essential;
- Delivery focus, flexibility, and a hands-on as appropriate to a small agency;
- Self-motivation, commitment and energy, with a passion to serve and protect the public interest;
- Ambition to assist in delivering on demanding strategic development targets with strong personal and professional credibility; and
- It is desirable that the successful candidate will have at least 3 years relevant experience.

Applicants must demonstrate by reference to specific achievements that they possess the qualities, skills and knowledge required for the role of Higher Executive Officer as identified by the Public Appointments Service (PAS) capability framework.

If this sounds like you, then the application process is set out below.

Application Process

Persons interested in this role should submit an application to recruitment@pcsaireland.ie citing the title of the position for which you wish to apply, and including:

- A comprehensive CV, (see CV Guidance Note in Appendix 1 of this Booklet);
- A completed Key Capabilities Form, setting out specific examples demonstrating each capability. An overview of the relevant key competencies

for this role, and the Key Capabilities Form, are provided in Appendix 2 of this Booklet; and

• A short cover letter (no more than one page in length) outlining why you wish to be considered for the post.

The deadline for the receipt of applications is 3.00pm on 21st May 2025 and late applications will not be considered.

Selection Process

The selection process for this post may include some or all of the following:

- Shortlisting on the basis of the information supplied by candidates in their application to select a number of candidates to be invited to competitive interview;
- A preliminary interview;
- A presentation exercise, to be undertaken as part of a preliminary or final competitive interview, work sample / role play, or any other tests or exercises that may be deemed appropriate; and
- A final selection interview if deemed necessary.

During any shortlisting exercise which may be employed, applications will be examined and assessed against pre-determined criteria based on the requirements of the position. The selection board will examine the information provided in your application and assess it against these criteria. It is therefore in your own interests to provide a detailed and accurate account of your qualifications and experience.

Candidates who are successful at the shortlisting stage will be invited to attend a competitive interview. Interviews are expected to take place during the month of January.

Candidates should ensure that they are available to participate, if shortlisted, at the interview stage.

While, we endeavour to give as much notice as possible for interview dates, the onus is on all applicants to make themselves available on the date(s) specified by the Authority for interview and to make whatever arrangements are necessary to ensure that they receive communications sent to them throughout the competition

process.

Interviews may take place by attending in person at the offices of the PCSA or such other place as may be notified to the candidate.

References

We request that you include in your CV the names of people you feel would be suitable referees that we might consult (two to three names and contact details), one of which should be your current employer. Please be assured that we will only contact your referees with your consent should you come under consideration for appointment.

Security Clearance

An applicant will be required to undergo a Garda Vetting process and other security clearance, as appropriate, should they come under consideration for appointment to the position.

Canvassing

Candidates should note that canvassing will disqualify and will result in their exclusion from the process. Candidates must not:

- knowingly or recklessly provide false information;
- canvass any person with or without inducements;
- personate a candidate at any stage of the process;
- · attempt to influence a decision of any person in relation to that process; or
- interfere with or compromise the process in any way.

These actions will result in the disqualification of the candidate and their exclusion from the process.

Where the Authority is of the opinion that there may have been interference or attempted interference with an appointment process, it may investigate the matter or cause it to be investigated by a person authorised on its behalf. Authority Members, staff and selection board members are obliged by their Code of Conduct to report any approach to them by or on behalf of a candidate to the Chairperson, Chief Executive or Chair of the Audit and Risk Committee of the Authority, as appropriate.

Deeming of Candidature to be withdrawn

Candidates who do not attend for interview or other test, exercise or appointment when and where required by the Authority, or who do not, when requested, furnish such information or evidence as the Authority requires in regard to any matter relevant to their candidature, will be deemed to have withdrawn from the competition and will have no further claim to consideration.

Confidentiality and Data Protection

Protecting confidentiality is a priority for the Authority. All applications, tests, enquiries, and all aspects of the selection, vetting and appointments process are treated as strictly confidential, subject to the statutory framework and, unless required by law, are not disclosed to anyone other than those directly involved in the selection competition, clearance, or appointments process.

All data will be processed in accordance with the General Data Protection Regulation and relevant Data Protection law.

When an application form is received, a record will be created in the candidate's name which contains much of the personal information supplied. This personal record is used to process the application and is held in accordance with the General Data Protection Regulation (GDPR) and relevant data protection law. Certain items of information, not specific to any individual, may be extracted from records for general statistical purposes.

The Authority's Candidate Privacy Notice, which provides more detailed information on what categories of candidate data are processed and how they are used, is available for download from our website.

Request for Review / Complaints

This competition is being undertaken in accordance with the Commission for Public Service Appointments (CPSA) Code of Practice for Appointment to Positions in the Civil Service and Public Service.

If you are unhappy following the selection process, the CPSA's Code of Practice sets out the review and appeal mechanisms open to you. You can either request a review of a decision made during the selection process, under section 7 of the relevant code, or you can make a complaint that the selection process followed was unfair, under section 8. You must choose between requesting a review of a decision or making a complaint. You cannot choose both.

Request a review (section 7)

If you are unhappy with a decision made during a selection process, believe it was made on the basis of incorrect information or that documented procedure was not followed, you can ask for a review under section 7 of the code. The decision may be reversed if it is found to have been incorrect.

Make a complaint (section 8)

If you think the selection, process was unfair and in breach of the Code of Practice, you can make a complaint about the process under section 8 of the code. If the selection process is found to have been unfair, the decision will not be reversed. However, changes may be made to the process to ensure a breach does not happen again.

Candidates' Obligations

Candidates must ensure, in applying for a position, that they:

- Have the knowledge and ability to discharge the duties of the post concerned;
- Are suitable on the grounds of health and character; and

 Are suitable in all other relevant respects for appointment to the post concerned.

Candidates are required to:

- Provide any information required as part of the application process for the competition;
- Undertake any clearance process that may be required by the Authority; and
- Agree to perform the duties attached to the specified post and to accept the conditions under which those duties are or may be required to be performed.

Candidates are bound by the Code of Ethics for the Civil Service. 'Honesty and Integrity' is one of the key tenets of the Code. Candidates are expected to honour these values, both in how they approach this competition and by agreeing to follow the rules and procedures laid down.

By undertaking any required online tests or exercises, you are confirming that you are the person named on the application and agreeing to complete the test or exercise honestly and without assistance. By accessing or attempting any test/exercise materials or attending for interview you are agreeing to be bound by the terms set out in the Statement of Practice for this competition.

Candidates should be aware that if the information provided by a candidate at any stage in the selection or clearance process was found to be inaccurate or incomplete this would also be taken into account in assessing the suitability of the candidate for appointment. Candidates who knowingly or recklessly provide false or misleading information will not be considered for appointment.

A panel of candidates may be established by the Authority as a result of this competition, which will expire no later than one year from the date of its establishment. Being placed on a panel does not entitle a candidate to be appointed by the Authority.

The admission of a person to a competition, or invitation to attend interview, or a successful result letter, is not to be taken as implying that the PCSA is satisfied that such a person fulfils the requirements or is not disqualified by law from holding the position.

Prior to making an offer to a candidate as a result of this competition the PCSA will make all such enquiries that are deemed necessary to determine the suitability of that candidate.

Continuing Professional Development

The Authority supports participation in relevant training and professional development courses related to an employee's business activities.

Eligibility to compete and certain restrictions on eligibility

Citizenship Requirements

Eligible candidates must be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or

(d) A non-EEA citizen who has a Stamp 4 permission¹ or a Stamp 5 permission;

To qualify candidates must be eligible by the date of any job offer.

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility)

Incentivised Scheme for Early Retirement (ISER):

It is a condition of the Incentivised Scheme for Early Retirement (ISER), as set out in Department of Finance Circular 12/09, that retirees under that Scheme, are not eligible to apply for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position

Department of Health and Children Circular (7/2010):

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys.

The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme

and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will <u>not</u> be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Declaration

Applicants will be required to declare whether they have previously availed of a Public Service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

Employer of Choice

As an Employer of Choice the Civil Service has many flexible and family friendly policies, e.g. Work-sharing, Shorter Working Year, Remote Working (operated on a 'blended' basis), etc. All elective policies can be applied for in accordance with the relevant statutory provisions and are subject to the business needs of the organisation.

The Civil Service also operates a Mobility scheme for all general service grades.

This scheme provides staff with career opportunities to learn and partake in diverse roles across a range of Civil Service organisations and geographical locations.

PRINCIPAL CONDITIONS OF SERVICE

General

The appointment is to a permanent post in the Civil Service and is subject to the Civil Service Regulations Acts 1956 to 2005, the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to the Civil Service.

Pay

The salary scale for the position (rate effective from 1 March 2025) is as follows:

HIGHER EXECUTIVE OFFICER (PPC)

The PPC pay rate applies when the individual is required to pay a <u>Personal Pension</u> <u>Contribution</u> (otherwise known as a main scheme contribution) in accordance with the rules of their main/personal superannuation scheme. This is different to a contribution in respect of membership of a Spouses' and Children's scheme, or the Additional Superannuation Contributions (ASC).

A different rate will apply where the appointee is not required to make a Personal Pension Contribution.

Long service increments may be payable after 3(LSI1) and 6(LSI2) years satisfactory service at the maximum of the scale.

Important Note

Candidates should note that entry will be at the minimum of the salary scale and will not be subject to negotiation and the rate of remuneration may be adjusted from time to time in line with Government pay policy. Increments may be awarded subject to satisfactory performance.

You will agree that any overpayment of salary, allowances, or expenses will be repaid by you in accordance with Circular 07/2018: Recovery of Salary, Allowances, and Expenses Overpayments made to Staff Members/Former Staff Members/Pensioners.

Different terms and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil or Public Servant.

Tenure and Probation

The appointment is to a permanent position on a probationary contract in the Civil Service.

The probationary contract will be for a period of twelve months from the date specified on the contract. During the period of your probationary contract, your performance will be subject to review by your supervisor(s) to determine whether you –

- (i) Have performed in a satisfactory manner,
- (ii) Have been satisfactory in general conduct, and
- (iii) Are suitable from the point of view of health with particular regard to sick leave.

Prior to the completion of the probationary contract a decision will be made as to whether or not you will be retained pursuant to Section 5A(2) Civil Service Regulation Acts 1956–2005. This decision will be based on your performance assessed against the criteria set out in (i) to (iii) above. The detail of the probationary process will be explained to you by your Manager and you will be given a copy of the Department of Public Expenditure NDP Delivery and Reform's guidelines on probation.

Notwithstanding the preceding paragraphs in this section, the probationary contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

In the following circumstances your contract may be extended and your probation period suspended.

• The probationary period stands suspended when an employee is absent due to Maternity or Adoptive Leave.

- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with the continuation of the probation and
- Any other statutory provision providing that probation shall -
 - (i) stand suspended during an employee's absence from work, and
 - (ii) be completed by the employee on the employees return from work after such absence.

Where probation is suspended the employer should notify the employee of the circumstances relating to the suspension.

All appointees will serve a one-year probationary period. If an appointee who fails to satisfy the conditions of probation has been a serving civil servant immediately prior to their appointment from this competition, the issue of reversion will normally arise. In the event of reversion, an officer will return to a vacancy in their former grade in their former Department.

Location

The office's location will be at 90 King Street North, Dublin 7. However, this may change and will be such as may be designated from time to time by the Authority. The Organisation operates a blended working policy and all staff are entitled to apply for blended working on an annual basis. Currently the working pattern is two days in the office and three days working remotely, following an initial two week settling in period in the office. When absent from home and headquarters on official duty, the appointee will be paid appropriate travelling expenses and subsistence allowances, subject to normal civil service regulations.

Unfair Dismissals Acts 1977-2015

The Unfair Dismissals Acts 1977–2015 will not apply to the termination of this employment by reason only of the expiry of this probationary contract without it being renewed.

The Organisation of Working Time Act

The terms of the Organisation of Working Time Act 1997 will apply, where appropriate, to this employment.

Hours of Attendance

Hours of attendance will be fixed from time to time but will amount to not less than 41 hours 15 minutes gross or 35 hours net per week. The successful candidate/s will be required to work such additional hours from time to time as may be reasonable and necessary for the proper performance of his / her duties, subject to the limits set down in the working time regulations. Where extra attendance is necessary, overtime payments, or time off in lieu, will be allowed in accordance with the Civil Service overtime regulations.

Annual Leave

The annual leave allowance for the position is currently 29 days rising to 30 days after 5 years' service. This allowance is subject to the usual conditions regarding the granting of annual leave in the civil service, is based on a five-day week and is exclusive of the usual public holidays.

Sick Leave

Pay during properly certified sick absence, provided there is no evidence of permanent disability for service, will apply on a pro-rata basis, in accordance with the provisions of the sick leave circulars.

Officers who will be paying Class A rate of PRSI will be required to sign a mandate authorising the Department of Social Protection to pay any benefits due under the Social Welfare Acts directly to the Authority. Payment during illness will be subject to the officer making the necessary claims for social insurance benefit to the Department of Social Protection within the required time limits.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie.

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career

break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is the same as the age of eligibility for the State Pension, currently 66.
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

Pension Abatement

• If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her reemployment that pension will be subject to abatement in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012.

Special arrangements may, however be made for the

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

Ill-Health-Retirement

Please note any person who previously retired on ill health grounds under the terms of a superannuation scheme are required to declare, at the initial application phase, that they are in receipt of such a pension to the organisation administering the recruitment competition.

Applicants will be required to attend the CMO's office to assess their ability to provide regular and effective service taking account of the condition which qualified them for IHR.

Appointment post ill-health retirement from Civil Service

If successful in their application through the competition, the applicant should to be aware of the following:

This may have implications for any appointee who has acquired pension rights in a previous public service employment.

Additional Superannuation Contribution

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017. Note: ASC deductions are in addition to any pension contributions (main scheme and spouses' and children's contributions) required under the rules of your pension scheme.
